1. Introduction

This statement tells you about our charges and the reasons behind them. It has been prepared consistent with Standard Licence Condition 14 of our Electricity Distribution Licence. The main purpose of this statement is to provide our schedule of charges (which can be positive or negative) for the use of our Distribution System and to provide the schedule of adjustment factors (also known as Line Loss Factors¹) that should be applied in Settlement to account for losses from the Distribution System. We have also included guidance notes in Appendix 2 – Guidance notes to help improve your understanding of the charges we apply.

Within this statement we use terms such as ‘Users’ and ‘Customers’ as well as other terms which are identified with initial capitalisation. These terms are defined in the glossary.

The charges in this statement are determined using Vattenfall Networks Limited’s use of system charging methodology.

Separate charges are calculated depending on the characteristics of the connection and whether the use of the Distribution System is for demand or generation purposes. Charges for a generation connection can be negative in which case the Supplier will receive credits for exported energy.

The application of charges to premises can usually be referenced using the Line Loss Factor Class (LLFC) contained in the charge tables. Further information on how to identify and calculate the charge that will apply for your premise is provided in the guidance notes in Appendix 2.

All charges in this statement are shown exclusive of VAT. Invoices will include VAT at the applicable rate.

The annexes that form part of this statement are also available in spreadsheet format. This spreadsheet contains supplementary information used for charging purposes and a simple model to assist you to calculate charges. The spreadsheet can be downloaded at: <https://networks.vattenfall.co.uk>

1.1. Validity period

This charging statement is valid for services provided from the effective from date stated on the front of the statement and remains valid until updated by a revised version or superseded by a statement with a later effective from date.

When using this charging statement care should be taken to ensure that the statement or statements covering the period that is of interest are used. 2. Application and Determination of Charges

The following section details how the charges in this statement are applied and billed to Users of our Distribution System.

2.1. Billing approaches

We utilise two billing approaches depending on the type of metering data received:

- The '**Supercustomer**' approach for Customers for whom we receive aggregated consumption data through Settlement; and
- The '**Site-specific**' approach for Customers for whom we receive site-specific consumption data through Settlement.

We receive **aggregated consumption** data through Settlement for:

- a) Domestic and non-domestic Customers for whom Non-Half Hourly (NHH) metering data is used in Settlement (i.e. Customers with MPANs which are registered to Measurement Class A);
- b) Customers which are unmetered and are not settled as pseudo Half Hourly (HH) metered (i.e. Customers with MPANs which are registered to Measurement Class B);
- c) Domestic Customers for whom HH metering data is used in Settlement (i.e. Customers with MPANs which are registered to Measurement Class F); and
- d) Non-domestic Customers for whom HH metering data is used in Settlement and which have whole current (WC) metering (i.e. Customers with MPANs which are registered to Measurement Class G).

We receive **site specific** consumption data through Settlement for:

- a) Non-domestic Customers for whom HH metering data is used in Settlement and which have current transformer (CT) metering (i.e. Customers with MPANs which are registered to measurement class C or E); and
- b) Customers which are unmetered and settled as pseudo HH metered (i.e. Customers with MPANs which are registered to measurement class D).

2.2. Supercustomer billing and payment

The Supercustomer approach makes use of aggregated data obtained from Suppliers using the 'Aggregated Distribution Use of System (DUoS) Report' data flow.

Invoices are calculated on a periodic basis and sent to each User for whom we transport electricity through our Distribution System. Invoices are reconciled over a period of approximately 14 months to reflect later and more accurate consumption figures.

The charges are applied on the basis of the LLFC assigned to the MPAN, and the units (or kWhs) consumed within the time periods specified in Annex 1. These time periods are not the same as those indicated by the Time Pattern Regime (TPR) assigned to the Standard Settlement Configuration (SSC). All LLFCs are assigned at our sole discretion, based on the tariff application rules set out in the appropriate charging methodology or elsewhere in this statement. Please refer to the section 'Incorrectly allocated charges' if you believe the allocated LLFC or tariff is incorrect.

2.3. Supercustomer charges

Supercustomer charges include the following components:

- A **fixed charge** – pence/MPAN/day; there will be only one fixed charge applied to each MPAN; and
- **Unit charges** – pence/kwh; three unit charges will apply depending on the time of day and the type of tariff for which the MPAN is registered.

Users who supply electricity to a Customer whose MPAN is registered as Measurement Class A, B, F or G will be allocated the relevant charge structure set out in Annex 1.

Identification of the appropriate charge can be made by cross-reference to the LLFC.

Valid Settlement Profile Class (PC)/Standard Settlement Configuration (SSC)/Meter Timeswitch Code (MTC) combinations for LLFCs where the Metering System is Measurement Class A or B are detailed in Market Domain Data (MDD).

Where an MPAN has an invalid Settlement combination, the 'Domestic Aggregated' fixed and unit charges will be applied as default until the invalid combination is corrected. Where there are multiple SSC/TPR combinations, the default 'Domestic Aggregated' fixed and unit charges will be applied for each invalid SSC/TPR combination.

The 'Domestic Aggregated (Related MPAN)' and 'Non-Domestic Aggregated (Related MPAN)' charges are supplementary to their respective primary MPAN charge

2.4. Site-specific billing and payment

The site-specific billing and payment approach makes use of HH metering data at premises level received through Settlement.

Invoices are calculated on a periodic basis and sent to each User for whom we transport electricity through our Distribution System. Where an account is based on estimated data, the account shall be subject to any adjustment that may be necessary following the receipt of actual data from the User.

The charges are applied on the basis of the LLFCs assigned to the MPAN (or the (MSID) for Central Volume Allocation (CVA) sites), and the units consumed within the time periods specified in this statement.

All LLFCs are assigned at our sole discretion, based on the tariff application rules set out in the appropriate charging methodology or elsewhere in this statement. Please refer to the section 'Incorrectly allocated charges' if you believe the allocated LLFC or tariff is incorrect.

2.5. Site-specific billed charges

Site-specific billed charges for LV and HV Designated Properties may include the following components:

- a fixed charge, pence/MPAN/day or pence/MSID/day;
- a capacity charge, pence/kilovolt-ampere (kVA)/day, for Maximum Import Capacity (MIC) and/or Maximum Export Capacity (MEC);
- an excess capacity charge, pence/kVA/day, if a site exceeds its MIC and/or MEC;
- three unit charges, pence/kWh, depending on the time of day and the type of tariff for which the MPAN is registered; and
- a reactive power charge, pence/kilovolt-ampere reactive hour (kVArh), for each unit in excess of the reactive charge threshold.

Users who wish to supply electricity to Customers for whom we receive site-specific data through Settlement (see paragraph 2.4) will be allocated the relevant charge structure dependent upon the voltage and location of the Metering Point.

Fixed charges are generally levied on a pence per MPAN/MSID per day basis. Where two or more HH MPANs/MSIDs are located at the same point of connection (as identified in the Connection Agreement), with the same LLFC, and registered to the same Supplier, only one daily fixed charge will be applied.

LV and HV Designated Properties will be charged in accordance with the CDCM and allocated the relevant charge structure set out in Annex 1.

Designated EHV Properties will be charged in accordance with the EDCM and allocated the relevant charge structure set out in Annex 2.

Where LV and HV Designated Properties or Designated EHV Properties have more than one point of connection (as identified in the Connection Agreement) then separate charges will be applied to each point of connection.

2.6. Time periods

The time periods for the application of unit charges to metered LV and HV Designated Properties are detailed in Annex 1. We have not issued a notice to change the time bands.

The time periods for the application of unit charges to Unmetered Supply Exit Points are detailed in Annex 1. We have not issued a notice to change the time bands.

The time periods for the application of unit charges to Designated EHV Properties are detailed in Annex 2. We have not issued a notice to change the time bands

2.7. Application of capacity charges

The following sections explain the application of capacity charges and exceeded capacity charges.

2.8. Chargeable capacity

The chargeable capacity is, for each billing period, the MIC/MEC, as detailed below

The MIC/MEC will be agreed with us at the time of connection or pursuant to a later change in requirements. Following such an agreement (be it at the time of connection or later) no reduction in MIC/MEC will be allowed for a 12 month period.

Reductions to the MIC/MEC may only be permitted once in a 12 month period. Where the MIC/MEC is reduced the new lower level will be agreed with reference to the level of the Customer's maximum import and/or export demand respectively. The new MIC/MEC will be applied from the start of the next billing period after the date that the request was received. It should be noted that, where a new lower level is agreed, the original capacity may not be available in the future without the need for network reinforcement and associated charges.

In the absence of an agreement, the chargeable capacity, save for error or omission, will be based on the last MIC/MEC that we have previously agreed for the relevant premises' connection. A Customer can seek to agree or vary the MIC/MEC by contacting us using the contact details.

2.9. Exceeded capacity

Where a Customer takes additional unauthorised capacity over and above the MIC/MEC, the excess will be classed as exceeded capacity. The exceeded portion of the capacity will be charged at the excess capacity charge p/kVA/day rate, based on the difference between the MIC/MEC and the actual capacity used. This will be charged for the full duration of the billing period in which the breach occurs.

Demand exceeded capacity

$$\text{Demand Exceeded Capacity} = \max (2 * \sqrt{AI^2 + \max(RI, RE)^2} - MIC, 0)$$

Where:

AI = Active import (kWh)

RI = Reactive import (kVArh)

RE = Reactive export (kVArh)

MIC = Maximum import capacity (kVA)

Only reactive import and reactive export values occurring at times of active import are used in the calculation. Where data for two or more MPANs is aggregated for billing purposes the HH consumption values are summated prior to the calculation above.

This calculation is completed for every half hour and the maximum value from the billing period is applied.

Generation exceeded capacity

$$\text{Generation Exceeded Capacity} = \max (2 * \sqrt{AE^2 + \max(RI, RE)^2} - MEC, 0)$$

Where:

AE = Active export (kWh)

RI = Reactive import (kVArh)

RE = Reactive export (kVArh)

MEC = Maximum export capacity (kVA)

Only reactive import and reactive export values occurring at times of active export are used in the calculation. Where data for two or more MPANs is aggregated for billing purposes the HH consumption values occurring at times of kWh export are summated prior to the calculation above.

This calculation is completed for every half hour and the maximum value from the billing period is applied.

2.10. Standby capacity for additional security on site

Where standby capacity charges are applied, the charge will be set at the same rate as that applied to normal MIC. Should a Customer's request for additional security of supply require the provision of capacity from two different sources, we reserve the right to charge for the capacity held at each source.

2.11. Minimum capacity levels

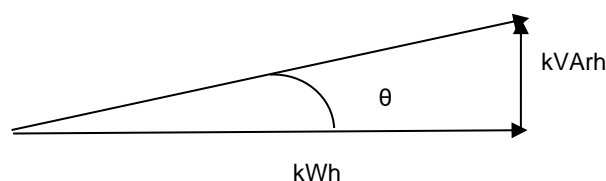
There is no minimum capacity threshold.

2.12. Application of charges for excess reactive power

When an individual HH metered MPAN's reactive power (measured in kVArh) at LV and HV Designated Properties exceeds 33% of its total active power (measured in kWh) in any given half hour, excess reactive power charges will apply. This threshold is equivalent to an average power factor of 0.95 during that half hour. Any reactive units in excess of the 33% threshold are charged at the rate appropriate to the particular charge.

Power Factor is calculated as follows:

$$\cos \theta = \text{Power Factor}$$



The chargeable reactive power is calculated as follows:

Demand chargeable reactive power

$$\text{Demand chargeable kVArh} = \max \left[\max(RI, RE) - \left[AI \times \sqrt{\left(\frac{1}{0.95^2} - 1 \right)} \right], 0 \right]$$

Where:

AI = Active import (kWh)

RI = Reactive import (kVArh)

RE = Reactive export (kVArh)

Only reactive import and reactive export values occurring at times of active import are used in the calculation. Where data for two or more MPANs is aggregated for billing purposes the HH consumption values are summated prior to the calculation above. For sites which are importing and exporting in the same HH, i.e. where active import is not equal to zero and active export is not equal to zero, use zero for reactive import and reactive export when calculating capacity taken. The square root calculation will be to two decimal places.

This calculation is completed for every half hour and the values summated over the billing period.

Generation chargeable reactive power

$$\text{Generation chargeable kVArh} = \max \left[\max(RI, RE) - \left[AE \times \sqrt{\left(\frac{1}{0.95^2} - 1 \right)} \right], 0 \right]$$

Where:

AI = Active import (kWh)

RI = Reactive import (kVArh)

RE = Reactive export (kVArh)

Only reactive import and reactive export values occurring at times of active export are used in the calculation. Where data for two or more MPANs is aggregated for billing purposes the HH consumption values are summated prior to the calculation above. For sites which are importing and exporting in the same HH, i.e. where active import is not equal to zero and active export is not equal to zero, use zero for reactive import and reactive export when calculating capacity taken. The square root calculation will be to two decimal places.

This calculation is completed for every half hour and the values summated over the billing period.

2.13. Incorrectly allocated charges

It is our responsibility to apply the correct charges to each MPAN/MSID. The allocation of charges is based on the voltage of connection, import/export details, metering information and, for some tariffs, the metering location. Where an MPAN/MSID is used for export purposes, the type of generation (intermittent or non-intermittent) also determines the allocation of charges.

We are responsible for deciding the voltage of connection. Generally, this is determined by where the metering is located and where responsibility for the electrical equipment transfers from us to the connected Customer.

The Supplier determines and provides us with the metering information and data. This enables us to allocate charges where there is more than one charge per voltage level. The metering information and data is likely to change over time if, for example, a Supplier changes an MPAN from non-domestic to domestic following a change of use at the premises. When we are notified this has happened we will change the allocation of charges accordingly.

If it has been identified that a charge may have been incorrectly allocated due to the metering information and/or data then a request for investigation should be made to the Supplier.

Where it has been identified that a charge may have been incorrectly allocated due to the voltage of connection, import/export details or metering location then a request to investigate the applicable charges should be made to us. Requests from persons other than the Customer or the current Supplier must be accompanied by a Letter of Authority

from the Customer; the current Supplier must also acknowledge that they are aware a request has been made. Any request must be supported by an explanation of why it is believed that the current charge should be changed, along with supporting information including, where appropriate, photographs of metering positions or system diagrams. Any request to change the current charge that also includes a request for backdating must include justification as to why it is considered appropriate to backdate the change.

An administration charge (covering our reasonable costs) may be made if a technical assessment or site visit is required, but we will not apply any charge where we agree to the change request.

Where we agree that the current LLFC/charge should be changed, then we will allocate the appropriate set of charges for the connection. Any adjustment will be applied from the date of the request, back to the date of the incorrect allocation or; up to the maximum period specified by the Limitation Act (1980) in England and Wales, which covers a six year period from the date of request, and the Prescription and Limitation (Scotland) Act 1973, which covers a five year period from the date of request; whichever is the shorter.

Any credit or additional charge will be issued to the relevant Supplier(s) who were effective during the period of the change.

Should we reject the request a justification will be provided to the requesting party. We shall not unreasonably withhold or delay any decision on a request to change the charges applied and would expect to confirm our position on the request within three months from the date of request.

2.14. Generation charges for pre-2005 designated EHV properties

We do not have any pre-2005 designated EHV properties.

2.15. Provision of billing data

Where HH metering data is required for UoS charging and this is not provided in accordance with the BSC or the Distribution Connection and Use of System Agreement (DCUSA), such metering data shall be provided to us by the User of the system in respect of each calendar month within five working days of the end of that calendar month.

The metering data shall identify the amount of energy conveyed across the Metering System in each half hour of each day and shall separately identify active and reactive import and export. Metering data provided to us shall be consistent with that received through the metering equipment installed.

Metering data shall be provided in an electronic format specified by us from time to time and, in the absence of such specification, metering data shall be provided in a comma-separated text file in the format of Master Registration Agreement (MRA) data flow D0275 (as agreed with us). The data shall be emailed to ldno.operations@vattenfall.com

We require details of reactive power imported or exported to be provided for all Measurement Class C and E sites. It is also required for CVA sites and Exempt Distribution Network boundaries with difference metering. We reserve the right to levy a charge on Users who fail to provide such reactive data. In order to estimate missing reactive data, a power factor of 0.9 lag will be applied to the active consumption in any half hour.

2.16. Out of area use of system charges

We do not have a Distribution Services Area.

2.17. Licensed distribution network operator charges

Licensed Distribution Network Operator (LDNO) charges are applied to LDNOs who operate Embedded Networks within our Distribution Services Area.

The charge structure for LV and HV Designated Properties embedded in networks operated by LDNOs will mirror the structure of the All-the-way Charge and is dependent upon the voltage of connection of each embedded network to the host DNO's network. The same charge elements will apply as those that match the LDNO's end Customer charges. The relevant charge structures are set out in Annex 4.

Where a NHH metered MPAN has an invalid Settlement combination, the 'LDNO HV: Domestic Aggregated' fixed and unit charges will be applied as default until the invalid combination is corrected. Where there are multiple SSC/TPR combinations, the default 'LDNO HV: Domestic Aggregated' fixed and unit charges will be applied for each invalid SSC/TPR combination.

The charge structure for Designated EHV Properties embedded in networks operated by LDNOs will be calculated individually. The relevant charge structures are set out in Annex 2.

For Nested Networks the relevant charging principles set out in DCUSA Schedule 21 will apply.

2.18. Licence exempt distribution networks

The Electricity and Gas (Internal Market) Regulations 2011 introduced new obligations on owners of licence exempt distribution networks (sometimes called private networks) including a duty to facilitate access to electricity and gas suppliers for customers within those networks.

When Customers (both domestic and commercial) are located within a licence exempt distribution network and require the ability to choose their own Supplier this is called 'third party access'. These embedded Customers will require an MPAN so that they can have their electricity supplied by a Supplier of their choice.

Licence exempt distribution networks owners can provide third party access using either full settlement metering or the difference metering approach.

2.18.1. Full settlement metering

This is where a licence exempt distribution network is set up so that each embedded installation has an MPAN and Metering System and therefore all Customers purchase electricity from their chosen Supplier. In this case there are no Settlement Metering Systems at the boundary between the licensed Distribution System and the exempt distribution network.

In this approach our UoS charges will be applied to each MPAN.

2.18.2. Difference metering

This is where one or more, but not all, Customers on a licence exempt distribution network choose their own Supplier for electricity supply to their premises. Under this approach the Customers requiring third party access on the exempt distribution network will have their own MPAN and must have a HH Metering System.

2.18.3. Gross settlement

Where one of our MPANs is embedded within a licence exempt distribution network connected to our Distribution System, and difference metering is in place for Settlement purposes and we receive gross measurement data for the boundary MPAN, we will continue to charge the boundary MPAN Supplier for use of our Distribution System. No charges will be levied by us directly to the Customer or Supplier of the embedded MPAN(s) connected within the licence exempt distribution network.

We require that gross metered data for the boundary of the connection is provided to us. Until a new industry data flow is introduced for the sending of such gross data, gross metered data shall:

- be provided in a text file in the format of the D0036 MRA data flow;
- the text file shall be emailed to ldno.operations@vattenfall.com;
- the title of the email should also contain the phrase gross data or difference metered private network;
- the text file and the title of the email shall contain the metering reference specified by us in place of the Settlement MPAN, i.e. a dummy alphanumeric reference to enable the relating of the gross metered data to a given boundary MPAN; and
- the text filename shall be formed of the metering reference specified by us followed by a hyphen and followed by a timestamp in the format and followed by a timestamp in the format YYYYMMDDHHMMSS and followed by ".txt";

For the avoidance of doubt, the reduced difference metered measurement data for the boundary connection that is to enter Settlement should continue to be sent using the Settlement MPAN.

2.18.4. Net settlement

Where one of our MPANs is embedded within a licence exempt distribution network connected to one of our Distribution Systems, and difference metering is in place for Settlement purposes, and we **do not** receive gross measurement data for the boundary MPAN, we will charge the boundary MPAN Supplier based on the net measurement for use of our Distribution System. Charges will also be levied directly to the Supplier of the embedded MPAN(s) connected within the licence exempt distribution network based on the actual data received.

The charges applicable for the embedded MPANs are unit charges only. These will be the same values as those at the voltage of connection to the licence exempt distribution network and are shown in Annex n. The fixed charge and capacity charge, at the agreed MIC/MEC of the boundary MPAN, will be charged to the boundary MPAN Supplier.

3. Schedule of Charges for Use of the Distribution System

Tables listing the charges for use of our Distribution System are published in the annexes to this document.

These charges are also listed in a spreadsheet which is published with this statement and can be downloaded at <https://networks.vattenfall.co.uk>.

Annex 1 contains charges applied to LV and HV Designated Properties.

Annex 2 contains the charges applied to our Designated EHV Properties and charges applied to LDNOs for Designated EHV Properties connected within their embedded Distribution System.

Annex 3 contains details of any preserved and additional charges that are valid at this time. Preserved charges are mapped to an appropriate charge and are closed to new Customers.

Annex 4 contains the charges applied to LDNOs in respect of LV and HV Designated Properties connected in their embedded Distribution System.

4. Schedule of Line Loss Factors

4.1. Role of line loss factors in the supply of electricity

Electricity entering or exiting our Distribution System is adjusted to take account of energy that is lost as it is distributed through the network. This adjustment does not affect distribution charges but is used in energy settlement to take metered consumption to a notional grid supply point so that Suppliers' purchases take account of the energy lost on the Distribution System.

We are responsible for calculating the Line Loss Factors (LLFs) and providing these to Elexon. Elexon is the company that manages the BSC. This code covers the governance and rules for the balancing and settlement arrangements.

LLFs are used to adjust the Metering System volumes to take account of losses on the Distribution System.

4.2. Calculation of line loss factors

LLFs are calculated in accordance with BSC procedure 128 which sets out the procedure and principles with which our LLF methodology must comply. It also defines the procedure and timetable by which LLFs are reviewed and submitted.

LLFs are calculated for a set number of time periods during the year using either a generic or site-specific method. The generic method is used for sites connected at LV or HV and the site-specific method is used for sites connected at EHV or where a request for site-specific LLFs has been agreed. Generic LLFs will be applied as a default to all new EHV sites until sufficient data is available for a site-specific calculation.

The definition of EHV used for LLF purposes differs from the definition used for defining Designated EHV Properties in the EDCM. The definition used for LLF purposes can be found in our LLF methodology. The Elexon website <http://www.elexon.co.uk/operations-settlement/losses/> contains more information on LLFs.

4.3. Publication of line loss factors

The LLFs used in Settlement are published on the Elexon portal website, www.elexonportal.co.uk. The website contains the LLFs in standard industry data formats and in a summary form. A user guide with details on registering and using the portal is also available.

The BSC procedure 128 sets out the timetable by which LLFs are submitted and audited. The submission and audit occurs between September and December in the year prior to the LLFs becoming effective. Only after the completion of the audit at the end of December and BSC approval are the final LLFs published.

Illustrative LLFs based on the latest submitted LLFs are provided in Annex 5 of this statement. These illustrative LLFs are provided with reference to the metered voltage or associated LLFC for generic LLFs and by reference to the LLFCs for site-specific LLFs. Each LLF is applicable to a defined time period.

As this charging statement is published a complete year before the LLFs have been published it is important to note that the LLFs provided in this statement are for illustration only and may be revised during the BSC procedure 128 process.

When using the tables in Annex 5, reference should be made to the LLFC allocated to the MPAN to find the appropriate values.

5. Notes for designated EHV Properties

5.1. EDCM network group costs

We do not currently have any EDCM network group costs for our own systems. EDCM network group costs from host DNO systems are published in their charging statements.

These are illustrative of the modelled costs at the time that this statement was published. A new connection will result in changes to current network utilisations, which will then form the basis for future prices. The charge determined in this statement will not necessarily be the charge in subsequent years because of the interaction between new and existing network connections and any other changes made to our Distribution System which may affect charges.

5.2. Charges for new Designated EHV Properties

Charges for any new Designated EHV Properties calculated after publication of the current statement will be published on our website in an addendum to that statement as and when necessary. The addendum will include charge information of the type found in Annex 2, and LLFs as found in Annex 5.

The form of the addendum is detailed in Annex 6 to this statement. The addendum will also be sent to all relevant DCUSA parties (i.e. the registered Supplier) and where requested the Customer.

The new Designated EHV Properties' charges will be added to Annex 2 in the next full statement released

5.3. Charges for amended Designated EHV Properties

Where an existing Designated EHV Property is modified and energised in the charging year, we may revise the EDCM charges for the modified Designated EHV Property. If revised charges are appropriate, an addendum will be sent to all relevant parties and published as a revised 'Schedule of Charges and Other Tables' spreadsheet on our website. The modified Designated EHV Property charges will be added to Annex 2 in the next full statement released

5.4. Demand-side management

New or existing Designated EHV Property Customers may wish to offer part of their MIC to be interruptible by us (for active network management purposes other than normal planned or unplanned outages) in order to benefit from any reduced UoS charges calculated using the EDCM.

Several options exist in which we may agree for some or the entire MIC to be interruptible. Under the EDCM the applicable demand capacity costs would be based on the MIC minus the capacity subject to interruption. If you are interested in making part or all of your MIC interruptible as an integral irrevocable feature of a new connection or modification to an existing connection, you should in the first instance contact our connections function by email at: ido.operations@vattenfall.com

You must make an express statement in your application that you have an interest in some or all of the import capacity being interruptible for active network management purposes. If you are proactively interested in voluntarily but revocably offering to make some or all of your existing connection's MIC interruptible you should in the first instance contact us by email.

6. Electricity distribution rebates

We have neither given nor announced any DUoS rebated to Users in the 12 months preceding the date of publication of this revision of the statement.

7. Accounting and Administration Services

We reserve the right to impose payment default remedies. The remedies are as set out in DCUSA where applicable or else as detailed in the following paragraph.

If any invoices that are not subject to a valid dispute remain unpaid on the due date, late payment interest (calculated at base rate plus 8%) and administration charges may be imposed.

Our administration charges are detailed in the following table. These charges are set at a level which is in line with the Late Payment of Commercial Debts Act.

8. Supplier of Last Resort and Eligible Bad Debt Pass-Through Costs

8.1. Supplier of Last Resort

Our charges will recover the amounts payable to upstream network operators as a result of charges which they recover in line with their Standard Licence Condition 38B 'Treatment of payment claims for last-resort supply where Valid Claim is received on or after 1 April 2019'.

These charges may include, where relevant, amended charges which have previously been published as a result of Last Resort Supply Payment claims which have breached the Materiality Threshold in line with Distribution Services Provider's licence condition SLC38B

8.2. Eligible Bad Debt

Our charges will recover the amounts payable to upstream network operators as a result of charges which will recover the amount of Use of System bad debt the Authority has consented to be recovered.

8.3. Tables of Fixed Adders

Tables listing the charges to recover Supplier of Last Resort and Eligible Bad Debt passthrough costs are published in annex 7 to this document

9. Charges for Electrical Plant Provided Ancillary to the Grant of Use of System

No charges for plant provided ancillary to the grant of Use of System are detailed within this statement.

Appendix 2 – Guidance notes

Background

The electricity bill from your Supplier contains an element of charge to cover electricity distribution costs. This distribution charge covers the cost of operating and maintaining a safe and reliable Distribution System that forms the ‘wires’ that transport electricity between the national transmission system and end users such as homes and businesses. Our Distribution System includes overhead lines, underground cables, as well as substations and transformers.

In most cases, your Supplier is invoiced for the distribution charge and this is normally part of your total bill. In some cases, for example business users, the Supplier may pass through the distribution charge as an identifiable line item on the electricity bill.

Where electricity is generated at a property your Supplier may receive a credit for energy that is exported on to the Distribution System. These credits are intended to reflect that the exported generation may reduce the need for traditional demand led reinforcement of the Distribution System.

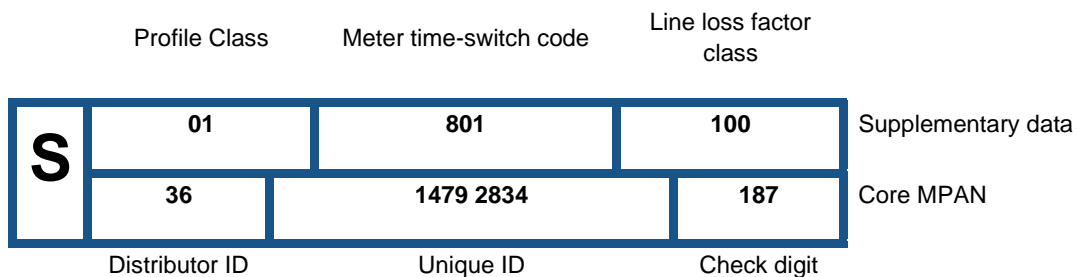
Understanding your distribution charges could help you reduce your costs and increase your credits. This is achieved by understanding the components of the charge to help you identify whether there may be opportunities to change the way you use the Distribution System.

Meter point administration

We are responsible for managing the electricity supply points that are connected to our Distribution System. Typically, every supply point is identified by a Meter Point Administration Number (MPAN). A few supply points may have more than one MPAN depending on the metering configuration (e.g. a school which may have an MPAN for the main supply and an MPAN for catering).

The full MPAN is a 21 digit number, preceded by an ‘S’. The MPAN applicable to a supply point is found on the electricity bill from your Supplier. This number enables you to establish who your electricity distributor is, details of the characteristics of the supply and importantly the distribution charges that are applicable to your premises.

The 21-digit number is normally presented in two sections as shown in the following diagram. The top section is supplementary data which gives information about the characteristics of supply, while the bottom ‘core’ is the unique identifier.



Generally, you will only need to know the Distributor ID and line loss factor class to identify the distribution charges for your premises. However, there are some premises where charges are specific to that site. In these instances, the charges are identified by the core MPAN. The Distributor ID for Vattenfall Networks is 36. Other Distributor IDs can be referenced in the glossary.

Additionally it can be useful to understand the profile class provided in the supplementary data. The profile class will be a number between 00 and 08. The following list provides details of the allocation of profile classes to types of customers:

- '01' – Domestic customers with unrestricted supply
- '02' – Domestic customers with restricted load, for example off-peak heating
- '03' – Non-domestic customers with unrestricted supply
- '04' – Non-domestic customers with restricted load, for example off-peak heating
- '05' – Non-domestic maximum demand customers with a Load Factor of less than 20%
- '06' – Non-domestic maximum demand customers with a Load Factor between 20% and 30%
- '07' – Non-domestic maximum demand customers with a Load Factor between 30% and 40%
- '08' – Non-domestic maximum demand customers with a Load Factor over 40% or non-half hourly metered generation customers
- '00' – Half-hourly metered demand and generation customers

Unmetered Supplies will be allocated to profile class 01, 08 and 00 depending on the type of load or the measurement method of the load.

The allocation of the profile class will affect your charges. If you feel that you have been allocated the wrong profile class, please contact your Supplier as they are responsible for this.

Your charges

All distribution charges that relate to our **Distributor ID 36** are provided in this statement.

You can identify your charges by referencing your line loss factor class, from Annex 1. If the MPAN is for a Designated EHV Property, then the charges will be found in Annex 2. In a few instances, the charges may be contained in Annex 3. When identifying charges in Annex 2, please note that some line loss factor classes have more than one charge. In this instance you will need to select the correct charge by cross referencing with the core MPAN provided in the table.

Once you have identified which charge structure applies to your MPAN then you will be able to calculate an estimate of your distribution charge using the calculator provided in the spreadsheet 'Schedule of charges and other tables' found in the sheet called 'Charge Calculator'. This spreadsheet can be downloaded from <https://networks.vattenfall.co.uk>.

Reducing your charges

The most effective way to reduce your energy charges is to reduce your consumption by switching off or using more energy efficient appliances. However, there are also other potential opportunities to reduce your distribution charges; for example, it may be beneficial to shift demand or generation to a better time period. Demand use is likely to be cheaper outside peak periods and generation credits more beneficial, although the ability to directly benefit will be linked to the structure of your supply charges.

The calculator mentioned above provides the opportunity to establish a forecast of the change in distribution charges that could be achieved if you are able to change any of the consumption related inputs.

Reactive power and reactive power charges

Reactive power is a separately charged component of connections that are half hourly metered. Reactive power charges are generally avoidable if 'best practice' design of the properties' electrical installation has been provided in order to maintain a power factor between 0.95 and unity at the Metering Point.

Reactive Power (kVAh) is the difference between working power (active power measured in kW) and total power consumed (apparent power measured in kVA). Essentially it is a measure of how efficiently electrical power is transported through an electrical installation or a Distribution System.

Power flowing with a power factor of unity results in the most efficient loading of the Distribution System. Power flowing with a power factor of less than 0.95 results in much higher losses in the Distribution System, a need to potentially provide higher capacity electrical equipment and consequently a higher bill for you the consumer. A comparatively small improvement in power factor can bring about a significant reduction in losses since losses are proportional to the square of the current.

Different types of electrical equipment require some 'reactive power' in addition to 'active power' in order to work effectively. Electric motors, transformers and fluorescent lighting, for example, may produce poor power factors due to the nature of their inductive load. However, if good design practice is applied then the poor power factor of appliances can be corrected as near as possible to source. Alternatively, poor power factor can be corrected centrally near to the meter.

There are many advantages that can be achieved by correcting poor power factor. These include: reduced energy bills through lower reactive charges, lower capacity charges and reduced power consumption and reduced voltage drop in long cable runs

Site-specific EDCM charges

A site classified as a Designated EHV Property is subject to a locational based charging methodology (referred to as EDCM) for higher voltage network users. Distributors use two approved approaches: Long Run Incremental Cost (LRIC) and Forward Cost Pricing (FCP). We mirror the approach used by the host DNO in the distribution services area. The EDCM will apply to Customers connected at Extra High Voltage or connected at High Voltage and metered at a HV substation.

EDCM charges and credits are site-specific, reflecting the degree to which the local and higher voltage networks have the capacity to serve more demand or generation without the need to upgrade the electricity infrastructure. The charges also reflect the networks specifically used to deliver the electricity to the site as well as the usage at the site. Generators with non-intermittent output and deemed to be providing beneficial support to our networks may qualify to receive credit.

The charges under the EDCM comprise of the following individual components:

- a) **Fixed charge** - This charge recovers operational costs associated with those connection assets that are provided for the 'sole' use of the customer. The value of these assets is used as a basis to derive the charge.
- b) **Capacity charge (pence/kVA/day)** - This charge comprises the relevant FCP/LRIC component, the National Grid Electricity Transmission cost and other regulated costs.

Capacity charges are levied on the MIC, MEC, and any exceeded capacity. You may wish to review your MIC or MEC periodically to ensure it remains appropriate for your needs as you may be paying for more capacity than you require. If you wish to make changes contact us via the information in this document.

The FCP/LRIC cost is locational and reflects our assessment of future network reinforcement necessary at the voltage of connection (local) and beyond at all higher voltages (remote) relevant to the customer's connection. This results in the allocation of higher costs in more capacity congested parts of the network reflecting the greater likelihood of future reinforcement in these areas, and the allocation of lower costs in less congested parts of the network. The local FCP/LRIC cost is included in the capacity charge.

Our regulated costs include direct and indirect operational costs and a residual amount to ensure recovery of our regulated allowed revenue. The capacity charge recovers these costs using the customer usage profile and the relevant assets being used to transport electricity between the source substation and customer's Metering Point.

- c) **Super-red unit charge (pence/kWh)** - This charge recovers the remote FCP/LRIC component. The charge is positive for import and negative for export which means you can either reduce your charges by minimising consumption or increasing export at those times. The charge is applied to consumption during the Super-red time period as detailed in Annex 2.

Future charge rates may be affected by consumption during the Super-red period, therefore reducing consumption in the Super-red time period may be beneficial.

Reactive Power -The EDCM does not include a separate charge component for any reactive power flows (kVAr) for either demand or generation. However, the EDCM charges do reflect the effect on the network of the customer's power factor, for example unit charges can increase if your site power factor is poor (lower than 0.95). Improving your site's power factor will also reduce the maximum demand (kVA) for the same power consumed in kW thus providing scope to reduce your agreed capacity requirements.
